

2025-2026 School Year Tuition and Fee Information K3 - 12th Grade

ENROLLMENT FEES (All fees are Non-Refundable and Non-Transferable. Payable through FACTS Management Only)

Application Fee: NEW students only -----\$125

Enrollment Fee: Due immediately upon acceptance of student application

Early enrollment, prior to March 1, 2025: \$75 discount per K3/K4 and \$100 discount per K5-12th grade student

 K3/K4: 5 day ½ day (8:30-11:45) ---- \$200

 K3/K4: Full Day (8:30-2:30) ---- \$240

 K5-12th grade: ---- \$280

Curriculum and Technology Fee: Due May 1, 2025 or at time of acceptance if after due date

Early enrollment, prior to March 1, 2025: \$50 discount per K3-12th grade student

Preschool (Half Day & Full Day)	\$300
Elementary (K5-5)	\$450
Middle School (6-8)	\$500
High School (9-12)	\$550

TUITION K3 - 12TH (Payable only through FACTS Management with multiple payment options, 3% tuition discount for payment in full)
Note: Starting in the 2025/2026 school year, the building fee will be included in the tuition for the oldest student. Tuition will also cover activity fees for field trips, middle/high school retreats, student insurance, ACSI fees, and class t-shirts.

PAYMENT POLICIES

All families **MUST** set up an automatic draft payment plan using the FACTS Tuition Management System and maintain a **valid and active account on file.** Failure to set up a payment plan will result in your child being placed on our waitlist. **FACTS Tuition Management is the only accepted method of payment for all charges.** *The only exceptions are payment in full by grandparents under the special gift tax exclusion and payment in full from a 529 plan.*

Returned Check Fees: There will be a \$30 return payment fee for any returned item.

Late Fees: A \$45 late fee will be assessed if a payment returns unpaid for any reason.

Suspension for Non-Payment: Students will not be allowed to attend class when their accounts become 30 days delinquent. Students are subject to dismissal if their account is not brought current within one week of their suspension. Student records will not be released until overdue accounts are satisfied.

Scholarship Endorsement: Failure to endorse with NCSEAA by their deadline will result in *automatic withdrawal* from BCA. Parents are responsible for following up with NCSEAA and following all requirements.

LATE ENROLLMENT

Students enrolling after May 1 will be considered late enrollees. Upon acceptance, the enrollment and curriculum fees must be paid via FACTS. Your child will not be assigned a seat in a classroom until payment is received and your FACTS Tuition Management account is fully set up with **automatic payments**. For students enrolling after the start of the school year, the tuition will be prorated based on the number of days they are enrolled.

WITHDRAWAL POLICY

Students are considered enrolled for the entire school year; therefore, budgets and teacher contracts are set accordingly.

Application and Enrollment Fees are non-refundable. Students who withdraw any time after May 1 will be assessed a \$300 Early Withdrawal Fee. Tuition will be prorated based on the number of days the student was enrolled. Official transcripts, report cards, and records will not be released or sent to other schools with an outstanding balance remaining.

PRESCHOOL POLICY

All preschool students must be fully potty trained and not dependent on a pacifier. Diapers, pull-ups, and pacifiers are not allowed due to sanitation guidelines. K3 students must be 3 by August 31st, and K4 students must be 4 by August 31st. A \$35 change fee will be assessed each time a change in schedule is requested after the start of school.

BEFORE AND AFTER SCHOOL CARE

Before School Care (BSC): Available daily starting at 7:00am, not available on any day when there is a schoolwide delay. This program will operate as a drop-in service and students may attend any day for a flat rate of \$5/day.

After School Care (ASC): Begins at dismissal and ends promptly at 6:00pm

\$175/month payable in nine payments: First payment September 5 and ninth payment May 5

A set fee is charged for ASC, regardless of the number of hours it is used. Families must register and pay a non-refundable registration fee of \$100. (More information regarding the program will be sent via email in August) Students will be enrolled for the entire school year, and those who withdraw from ASC during the school year may not return to the program for the rest of that year. Charges are due for the entire month if the child attended any day and will not be prorated. Payments will be made only through automatic payment on the FACTS Tuition Management System. Late registrants will be accepted only if space allows. ASC is not available on half-days, Professional Development Days or School Holidays.

Please note: If you pick your child up after 6:00pm, your account will be assessed a \$1 Late Pick-Up Fee for every 1 minute you are late. If your child is not enrolled and brought to ASC the charge is \$1 per minute attended. Habitual late pickup will result in automatic dismissal from the program.
